Mr Michał Wrzesiński holds a post-doctoral degree in economic sciences, is a professor at the Warsaw School of Economics' Department of Corporate Finance, and specialises in the capital market, mergers and takeovers, and private equity.

From 2006 until now he has been a member of the Management Board and Managing Partner of Navigator Capital Sp. z o.o.

From 2007 until now he has been President of the Management Board of Dom Maklerski Navigator S.A. and a member of the Management Board of Dom Inwestycyjny Navigator S.A.

He has also participated as an advisor in realising over 30 merger and takeover projects and capital transactions, both in Poland and in Central and Eastern Europe and Russia, with a total value of over PLN 2 billion.

Mr Michał Wrzesiński does not conduct any form of competitive activities in relation to PAMAPOL S.A., does not participate in a rival company as a partner of a civil or private partnership or as a member of a corporate body of

an incorporated entity, does not participate in any other rival legal person as a member of its corporate bodies and is not listed in the Register of Insolvent Debtors kept on the basis of the Act on the National Court Register.
